LuAnne Levens began riding at the age of 10, when her father's Army career landed the family in San Antonio, Texas. LuAnne's earliest experiences riding involved jumpers and cross country. She would eventually switch to the show hunter division, but became intrigued with the "combined training" division, which necessitated her learning dressage. She quickly abandoned the jumping to focus on her dressage, and joined the Potomac Valley Dressage Association in the late 1970s, and has served as the PVDA representative to the MHC board, beginning her involvement with MHC. She was publisher of the *Armed Forces Journal International* for many years. After selling the publication she joined Winchester homes in sales. In 1980 she began boarding horses at her Periwinkle Farm in Spencerville. She is the former secretary of the Eastern Montgomery Chamber of Commerce, a former member of the Eastern Montgomery Citizens Advisory Board, and a former Director on the Board for the Greater Silver Spring Chamber of Commerce.

Malcolm Commer is the Extension Equine Economist at the University of Maryland. He earned a BBS in 1970 and served, in the private sector, as livestock manager and general manager of an agribusiness holding company. Immediately after earning his doctorate in 1989, he accepted a faculty appointment with the University of Maryland. Grand Prix rider, trainer, and instructor, Elizabeth Madlener first came on the national scene in dressage when she was long-listed by the USET on her two Thoroughbreds Jonathan Swift and Gulliver, winning the World Cup screening trial (PSG) and finishing 8th in the 1980 Olympic trials. She has subsequently brought many horses and students to USDF, AHSA, USET regional and national awards. Elizabeth is the author of *Putting Your Horse on the Bit* as well as numerous articles, and for several years was a contributing editor to *Dressage Today*.

As president of the Maryland Horse Center in Gaithersburg, Elizabeth developed the only state recognized post-secondary school for equine professionals. She has served as secretary and then as president of the Maryland Horse Council, during which time she organized MHC into its present structure.

Currently, Elizabeth is an English professor at Prince George's Community College, and continues to train and teach dressage locally. As a USA Equestrian Senior Dressage judge and a USDF "L" Judges' Instructor, Elizabeth is a frequent flyer, traveling throughout the United States to judge, teach, and train.
