Whether you vote for a person or not, calling a candidate has a real benefit. It tells him that you care about the horse industry. He will remember these concerns when it comes time to vote on our issues. A good example is the "Right To Ride" bill that has been introduced in the U.S. House and Senate. Little or nothing has been heard from the horse people on this, so it's stalled in committee. They think we don't care. Write or call your congressman and senator, folks. You CAN make a difference. And if you think that your one little vote doesn't matter, just remember what happened in Florida in the 2000 election.
