

A Message from the President

(Steuart Pittman, Jr.)

Stuart Pittman, Jr. and his siblings are the 8th generation of his family to own their 550-acre Dodon Farm in Davidsonville, where he has made his living as a breeder, trainer and competitor in 3-day eventing for over 15 years. Stuart was Maryland's first eventing instructor to be certified by the USEA and he conducts clinics throughout the country. He has competed through the Advanced level on his Maryland-bred Thoroughbred stallion, Salute The Truth, who now stands at Dodon Farm. He graduated from the University of Chicago, then spent eight years as a political and community organizer before returning to the farm and horses. He became actively involved with the MHC during the campaign for the Maryland Horse Park. He created the Retired Racehorse Training Project, an educational organization that seeks to increase demand for Thoroughbred ex-racehorses. Stuart also served as MHC's President for four years.




Crystal Kimball is the owner and publisher of The Equiry. She rode on the University of Maryland equestrian team in college and has been involved with hunters, combined training, dressage, and foxchasing. She has been a

member of MHC since 1991, and serves on the board of directors as a Director-at-Large representing the business membership. Crystal also serves as secretary for the Maryland Steeplechase Association and technical advisor to the Maryland Horse Industry Board.



Stephen Fulton and his wife Karen have owned and operated Full Moon Farm in Finksburg since 1994. An 80-acre facility, Full Moon is a full-service barn offering boarding, lessons, a breeding program, horse shows

and schooling days, and two unrecognized starter horse trials. Stephen also operates a farrier service, serving clients in central Maryland and Northern Virginia. Stephen is a member of the MHC, MCTA, AFA, USEA, USEF, USHJA and AQHA. He is a former Level 3 ARIA instructor, has a BA in Equine Studies from Salem College, a Riding Master Certificate from Meridith Manor, and is a certified farrier graduate of the Oklahoma Farriers College.



Before joining the MHC Executive Committee, **Royce Herman** served on the MHC Board of Directors for seven years as the representative for Tuckahoe Equestrian Ctr. He graduated from Keystone College in 1966 and the University of Delaware School of Economics in 1971 and has spent over 40 years in food service marketing.

Royce is currently involved in trail riding, and has competed in Mounted Cowboy Shooting and mounted Wild West shows. For 13 years, Royce directed and acted in western shows for the Outlaw Days at Tuckahoe. He is a national competitor in muzzle loading bulls-eye pistol shooting and is a master gunsmith, owning and operating Centreville Gunsmith. Royce also teaches Hunter Safety for the State of Maryland and is a member of the Maryland Hunter Safety Instructor Hall of Fame.

Formal guidelines regarding what can/should be posted to the blogs are being created now. Examples of current information include: updates on Sunday Hunting, indoor arena building classification, and whether in house events (like a schooling show) can be labeled as "Agricultural Entities" in a particular county.

For the County Forums already established (Anne Arundel, Caroline, Carroll, Charles, Frederick, Howard, Montgomery, Prince George's, St. Mary's, and Talbot), Margaret has added the contact information for elected officials in each county, the 2010 Equine Census information, and the County-specific portion of the MHC Guide to County Zoning and Horses.

Horse Council PAC (*Win Hayward*)

The Horse Council Political Action Committee (PAC) has been active on a number of fronts this winter season. After hosting an energetic and extensive education session with State Legislators and staff at the Maryland Horse World Expo in January, we are grateful to have received numerous contributions that allow us to build resources and plan our next initiatives. Much of that work will be organized and carried in conjunction with the MHC Legislative Committee around such topics as the contributory negligence liability standard, animal cruelty, nutrient management, and racing, all of which are being discussed during the current State legislative session. Please express your views on key issues to leadership in either organization. Finally, as yet another indication of the PAC's growing maturity, the initial terms of PAC officers and Board of Directors are beginning to end and we are getting ready to take on new members. Royce Herman recently joined the Board as a member, and Rob Burk's term as Chair expires at the end of June. The new Chair will be appointed by the Executive Committee of the MHC; MHC members are encouraged to offer nominations and support.

MHC Update

Farm Stewardship (*Jane Thery*)

The Third Farm Stewardship meeting took place on February 18, 2013 in the comfortable and heated lounge of Lori Larson's lovely Wyndham Oaks Farm. Overlooking the impressive indoor arena, 25 members of the Maryland horse community gathered to discuss land stewardship issues with the overall goal of contributing to healthy horses and a healthy environment in Maryland.

Jane Thery, the committee chair, opened the meeting with an overview of the committee priorities of: promoting the view of the equestrian community in state-wide policy discussions regarding the environment; getting public recognition for the positive contribution to land management on the 587,000 acres in Maryland horse farms; linking technical and financial assistance resources to horse farm needs; staying ahead of the curve on land management technologies and regulations; and promoting the participation of horse farms in the Maryland Farm Stewardship Certification and Assessment Program (FSCAP).

Gerald Talbert, the program director of FSCAP, shared the good news that Sagamore Farm, owned by Kevin Plank and managed by Tom Mullikin, and the Potomac Horse Center, owned by the Maryland-National Capital Park and Planning Commission and managed by Rick Terselic, were certified. This brings the number of certified horse farms up to seven with acreage of 898.3. Again, congratulations to Persimmon Tree Farm and Carolyn Krome, Edgewood Farm and Steve Darcey, Bloomsbury Forge and Karla Stoner, Graden/ Rover's Content and Milly Welsh, Wyndham Oaks and Lori Larson, Potomac Horse Center and the Maryland-National Capitol Park and Planning Commission, and Sagamore Farm and Kevin Plank. Gerald answered questions from several farm owners looking into getting certified.

Lori Larson, the owner of Wyndham Oaks Farm, talked about designing the farm from the beginning to meet high environmental standards. Her experience with the FSCAP certification was that the process was simple as long as you had good farm management practices and kept your records up-to-date. Lori noted that she had also installed solar panels on the indoor arena roof and built the barns with natural light and ventilation. She is interested in exploring new technologies for on-farm energy generation using the horse manure from the 65 horses on the property. Wyndham Oaks has its Farm Stewardship green sign prominently displayed at the farm entrance.

Gary Felton, bio-environmental engineering and water quality specialist from the University of Maryland, is an expert on composting. He reviewed the simple steps to composting horse manure and highlighted its value as an organic soil enhancement. He also raised the issue of action needed to stop the use of persistent herbicides on equine hays and grains, as the herbicides do not break down in the composting process and can kill plants when the compost is applied. The Maryland Horse Council will look into ways to help stop the use of these persistent herbicides. Gary offered to provide additional information to anyone interested in composting horse manure.

Brenda Platt directs the Composting Makes \$en\$e Project at the Institute for Local Self Reliance and was representing the National

Composting Association. She raised the need to come up with modern composting regulations that will promote composting in a clear and transparent manner. She noted that the state of Maryland is presently reviewing composting regulations and encouraged the horse community to get involved. Brenda distributed a list of certified composting facilities that accept horse manure. The list was provided by Craig Coker of Coker Composting and Consulting. They are: Veteran's Compost in Aberdeen, Maryland; Howard County Bureau of Environmental Services in Marriottsville, Maryland (for Howard County horse farms only); Peninsula Compost in Wilmington, Delaware; Royal Oak Farm in Evington, Virginia; Black Bear Composting in Crozet, Virginia; McGill Environmental Systems in Waverly, Virginia; Two Particular Acres in Royersford, Pennsylvania; Terra-Grow, Inc. in Terre Hill, Pennsylvania; and Barnside Mulch and Compost in Schwenksville, Pennsylvania. She said that discussions are ongoing about building more composting facilities to manage the growing demand for composting in the region.

A special thanks to Andy Bennett of The Piedmont Group. Andy provided information on the insurance his company provides as well as some swag bag goodies to the group. He also sponsored our meeting refreshments. Thank you Andy!

Maryland Fund For Horses Spring Update (*Vicki Carson*)

Spring is here, and it's time for two important Maryland Fund For Horses (MFFH) programs: Responsible Horse Ownership Week, May 13-19 and Good-to-Geld/ Equine Healthcare Vouchers.

During Maryland's second annual Responsible Horse Ownership Week, MFFH will be offering a series of youth educational programs to organizations interested in educating young people about unwanted horses and responsible horse ownership. The program includes an interactive lesson plan with activities and resources appropriate for kids 8 and older. Summer camps, scout troops, lesson barns, pony clubs, 4-H groups and other organizations interested in the program should contact info@mdfundforhorses.org. Financial assistance with printing and volunteer instructors may be available for approved 501(c)(3) non-profit organizations.

This spring, MFFH is inaugurating its Equine Healthcare Voucher program. The program will be available to individuals in financial need, to assist with major (one-time) equine healthcare expenses. Examples include but are not restricted to gelding and euthanasia. Vouchers will be available as long as funds are available. Please help support this important program with your donations.
